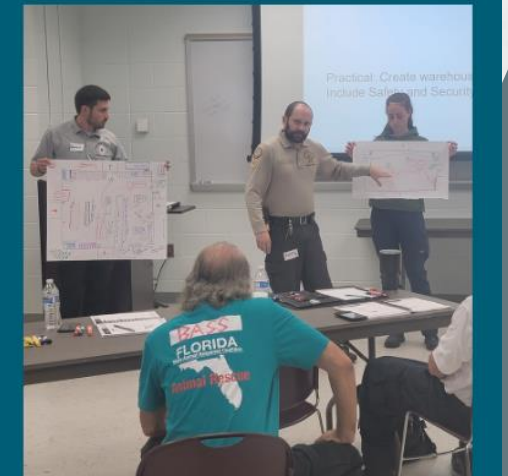

HISTORY



- Founded in 2011 as a 501 (c) 3 non - profit
- *Merged with SPCA Florida in September 2021 as a disaster response program*
- Over 250 Level 1 and Level 2 classes taught to date, including ONLINE beginning in 2020
 - *Many in FL, Several out of state: VA, OK, LA, GA*
- Over 4500 Students registered for courses
 - Approximately 2700 taught
 - Over 1200 registered as volunteers
 - Approximately 840 considered available to deploy or pending eligibility



HISTORY

- 2011: FOUNDED
- 2011 - present: Supported numerous FL State Exercises and Training
- 2012: Cat Caboodle (700 cats), Jacksonville FL
- 2017: Hurricane IRMA; Gainesville Hoarding
- 2018: Hurricane Michael
- 2019: Hurricane Dorian; Alaqua Animal Refuge - support for Holmes County 250 dogs hoarding case



- 2021: COVID-19 - Clay County hoarding (250+ animals)
- 2022: Hurricane Ian (several counties w/daily shelter care); HSUS - 4000 Beagles; ASPCA Nevada Sheltering Ops (300 dog cruelty); Kentucky Flooding Shelter Care; New Mexico Wild Fires; Citrus County Daily Shelter Care (80 dog hoarding case)
- 2023: HSUS 170 cat hoarding case MS; HSUS shelter assistance MD (200 dogs - over 80 rescued from S. Korean Dog Meat market industry)

8 Modules

Code of Conduct and Policies



Volunteers representing Florida SARC shall adhere to the following policies and code of conduct.

As a Florida SARC team member, working with or under Florida SARC

I will:

1. NOT SELF DEPLOY!
2. Project a professional manner and appearance while participating in any Florida SARC related activities.
3. Sign in and out daily
4. Honor my scheduled commitment
5. Attend all briefings on time
6. Wear my designated ID and approved uniform
7. Remember safety first and foremost for my team members and myself
8. Know my limitations, if I need help I will ask for help
9. Promote positive thinking and actions
10. Respect and follow prescribed Chain of Command
11. Keep an open mind and be flexible
12. Will not operate or act in any manner that is contrary to the best interests of Florida SARC and my team members
13. Will not speak to members of the media when deployed.
14. Avoid taking photographs & videos of animals or responders without approval.

As a Florida SARC member I will adhere to the following policies:

1. No personal animals allowed, except for service animals – be aware that service animals may be exposed to disease, parasites and other potentially life threatening illnesses and situations.
2. Smoking will be allowed only in designated areas. Cigarette butts must be disposed of safely and properly.
3. Consumption of any alcoholic beverages while on duty or any display of public drunkenness will not be tolerated and will result in immediate dismissal/expulsion.
4. Possession, use or selling of any illegal drugs, including abuse of prescription drugs will not be tolerated and will result in immediate dismissal/expulsion

Awareness Level (Level 1) - Introductory Level

- **The Disaster Process** - Understanding how disasters are managed.
- **Preparing for Deployment** - Checklists and considerations so you are ready when needed.
- **Building a Temporary Emergency Shelter** - Strategies for shelter location and design. Basic equipment assembly.
- **Animal Behaviors** - General understanding of animal behaviors, facial expressions, stresses, and more.
- **Daily Care** - Skills and procedures to provide daily care of animals.
- **Diseases & Parasites** - Processes and skills for recognizing and reporting illness.
- **Cleaning & Disinfecting** - Considerations to limit spread of disease. Procedures and options.
- **Tear Down & Cleanup** - Processes during tear down to improve readiness for the next disaster.

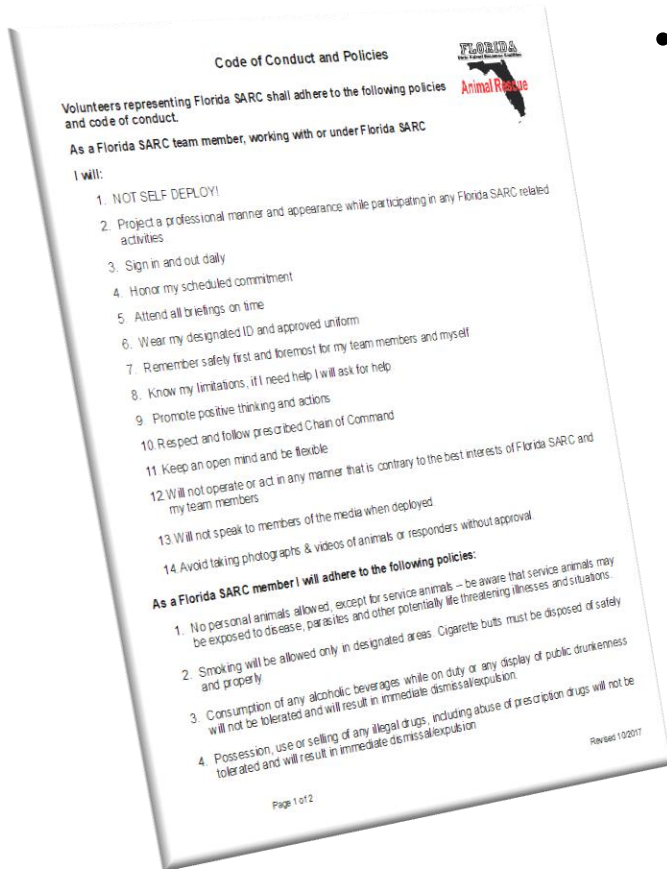
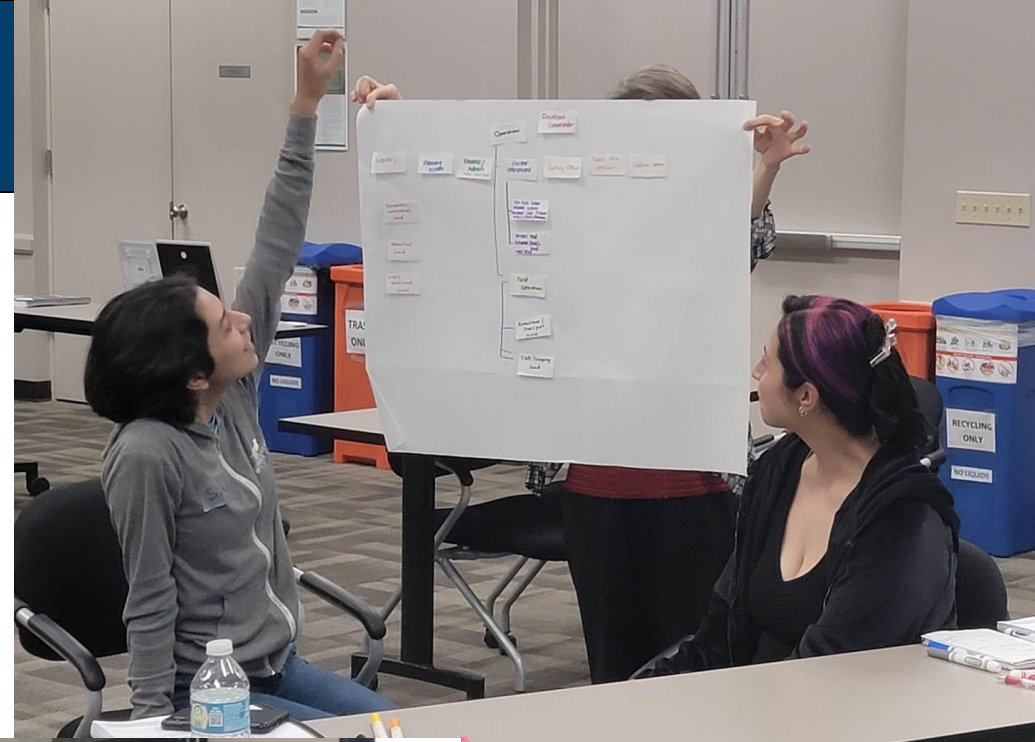

OPS (Level 2) – Advanced Level

Details leadership roles and strategic considerations of emergency animal shelters. Modules include:

• **Incident Command System** - How it is used in shelter operations

• **Biosecurity & Decontamination** – Includes understanding pathogens and concepts of decontamination

• **Facility Design Considerations** - Including locations, resources, and facility options

• **Supervising Volunteers** in emergencies

• **Leadership Roles** - Review Lead roles & their responsibilities in an emergency shelter.

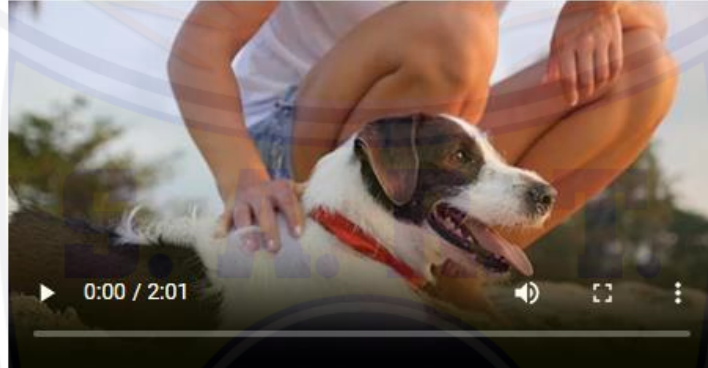

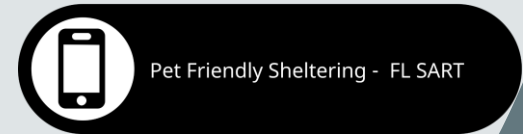
Course Overview

The Pet-Friendly Sheltering Online Training is the first of its kind to be offered in Florida. The training provides guidance to private, local and state entities on how to plan for and operate a pet-friendly shelter to ensure that individuals evacuating from a disaster with their household pets are accommodated. While this training will provide you with basic information and guidance, further training with local or state emergency management programs is essential to fully prepare for pet-friendly sheltering in your community. The Florida Department of Agriculture and Consumer Services developed this training collaboratively with the Florida State Agricultural Response Team (SART). This training is state-certified by the Florida Division of Emergency Management (Course Code FL-017).

Course Objectives

At the completion of this online training, you should be able to:

- Understand the benefits of and requirements for opening pet-friendly shelters during emergency evacuations.
- Understand the concept of the Incident Command System (ICS) and how it can be applied to pet-friendly shelter planning and operations.
- Identify strategies and planning considerations for writing a pet-friendly shelter plan for all-hazards.
- Understand the benefits of establishing partnerships and Multiagency Coordination Groups with key agencies and organizations to achieve local resource allocation for pet-friendly shelter preparedness.
- Understand the critical role social media plays in emergency communications, and how to develop an accurate and effective message about available pet-friendly shelters in a disaster.

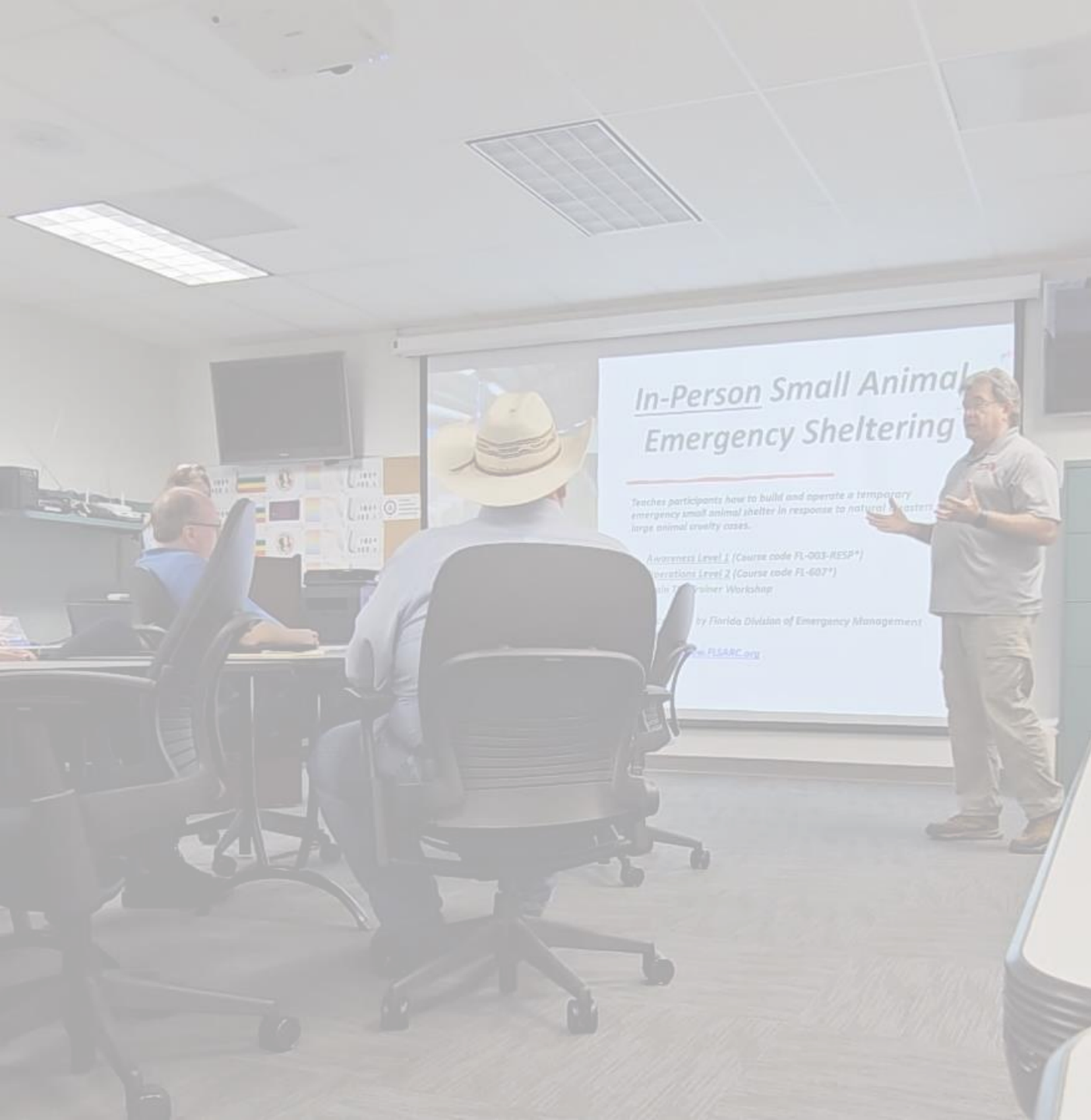
